HOW CAN ADVISORS PARTNER WITH RECRUITMENT?

REFRESHER: TROUBLESHOOTING

Student tells an advisor that they sent official transcripts to UNM several weeks ago but it's still not on their student record at UNM. What is the best protocol for this? Should we check OnBase first and then contact someone in Admissions? Who is the best contact?

RUMOR CONTROL

- Were students admitted for Fall 2018 without placement scores?
- What was the communication with the student for taking the Accuplacer?
- How can Admissions & Advisement partner on this in the future?

REFRESHER: FERPA – IS IT A VIOLATION?

SCENARIO #1

An out of state alumna calls and needs a copy of her LoboTrax Degree Audit but no longer has access to LoboTrax or her UNM email account. You ask a series of questions and when she answers them correctly you email her the degree audit to her non-UNM email account.

SCENARIO #2

Student prefers phone advisement because of his demanding work schedule. He signed off on a form indicating that he would allow phone advisement from a particular phone number. You make a phone appointment with him and call him at the number provided on that form and discuss his confidential student record with him over the phone.

REFRESHER: FERPA – IS IT A VIOLATION?

SCENARIO #3

A T.A. walks into your office. You know this T.A. has been hired to for a particular section of a course in your department but she is not listed on the schedule of classes as co-instructor. She was told by the instructor of record for the course to go to you to get a class list with student email addresses so that she (the T.A.) can email the students information about an assignment. Since you know the instructor and the T.A. well, you give her the class list.

SCENARIO #4 - A

You need to send an email to all the students that have been admitted to your department because they need to attend a Department Orientation. When you send the email, you CC all the students admitted to the email.

SCENARIO #4-B

At the orientation, you have the students pass around a sign-in sheet which requires they write in their name, email address, and UNM ID #.

REFRESHER: Qualifying Semester for Lottery

Student took MATH 264 as a dual enrollment student at UNM and earned a grade of "D." Student retakes MATH 264 during their qualifying semester. It is a repeat worth 0 hrs but since qualifying semesters are isolated, will the MATH 264 hours count toward qualifying for Lottery?

REFRESHER: MATH 180 vs MATH 162

• If a student takes MATH 180 under one major, then changes majors and is required to take MATH 162 they technically cannot earn credit for both. Is this ok for scholarships? Since we will be swapping the credit between MATH 180 and 162 will the student be able to use MATH 162 as hours toward their scholarship?

Do we then need to re-direct them to CNM to have Section II redone?
